A BYLAW TO AMEND FEES AND CHARGES BYLAW NO. 696, 2018

WHEREAS the Community Charter provides authority for Municipalities to establish various fees and charges, interests and penalties, terms and conditions, discounts and refunds;

AND WHEREAS, section 462 of the *Local Government Act* states that a local government, may, by bylaw, impose fees associated with land use applications, inspections and permits;
