Official Community Plan Workbook

In late October, the Village of Lytton invited residents, property owners, Nlaka'pamux governments, businesses and other community interests to provide feedback on future planning and development within the Village of Lytton through the update of the Official Community Plan (OCP).

This outreach provided an opportunity to document the **greater community's* aspirations and vision, with a strong focus on economic development. The Progress Report and engagement results have been compiled and are posted on the OCP Project web page: www.lytton.ca/OCP-update.

What is an Official Community Plan?

An Official Community Plan (OCP) is a guiding policy document that identifies a clear vision, objectives and policies that consider many aspects of planning and land use. In particular, the OCP considers how land use impacts future growth, housing supply, environmental, fiscal and community sustainability, transportation, parks, hazards, and servicing.

The current OCP was adopted in 1998 and needs to be updated to consider more recent amendments to provincial legislation, Nlaka'pamux engagement, impacts of the 2021 fire and atmospheric river events, and the changing Village demographics.

The next stage of the OCP's update process is to collect more detailed input on the directions of the document's vision and policies. This workbook has been prepared to receive comments from the community on the objectives and policy directions of the current OCP and incorporate ideas and comments received through the engagement.

**Greater community is defined in this workbook as considering communities that rely on Lytton as the regional centre, including the Nlaka'pamux and the Thompson–Nicola Regional District.*

1.0 What is an Official Community Plan Vision?

The current OCP does not include a vision. Including a vision in the OCP is valuable to Lytton, as it provides a descriptive and place-based statement about how a community strives to develop over the next 20 years. The vision is intended to be a touchstone to guide objectives, policies and actions. The vision should be unique to the Lytton community.

For reference, below please find several examples of visions contained within community plans for several locations throughout British Columbia:

- A. Town of Ucluelet** - Our built and natural environment reflects, above all, the value we place on the outstanding beauty and diverse natural habitat of this place, which support the well-being of all members of the community. Our residents and visitors enjoy a high quality of life built upon a sustainable, diverse and vibrant local economy.
- B. Village of Canal Flats** - Canal Flats is an affordable, family-friendly town building a new future in diverse housing options, quality of place initiatives, tourism and light industry development, and redevelopment of a unique work-live downtown. We will be a key employment centre in our Valley that reconnects people to nature ... and each other.
- C. Kanaka Bar Band** - We are committed to using its lands and resources to maintain a self-sufficient, sustainable and vibrant community.
- D. City of Powell River** - A Coastal city with a proud heritage, diverse local economy and a sustainable future - environmentally, socially and economically. With a superb natural setting, vast recreational opportunities, and vibrant arts & cultural services, we are a community for all ages. The pearl on the Sunshine Coast, we continue to work cooperatively with the Regional District and our Tla'amin Nation neighbours to foster a respectful community, inclusive for all.
- E. Lytton First Nation Tl'kemtsin** - A resilient, self-sufficient, and prosperous Nation grounded by a strong culture and language. We work together well and thrive with the teachings of our ancestors, the wisdom of our Elders, the strength of our leaders, and the guidance of our people.
- F. Village of Daajing Giids** - A hard working, healthy and sustainable community that welcomes the world. Daajing Giids (Queen Charlotte City) seeks to be a progressive, forward thinking community which strives to balance individual, environmental and economic needs within a safe, accessible and inclusive environment where we are free to live and prosper. Sensitive growth and development enables us to reduce our

footprint on the natural ecosystems while we endeavour to explore opportunities to use on Island alternative energy and agricultural sources. This meshes well with our interest in addressing climate change and in reducing greenhouse gas emissions.

G. District of Tumbler Ridge - In 2041, Tumbler Ridge is a unique gem in the Peace Region. Visitors are enchanted by the vast natural beauty and rich geological history unique to Tumbler Ridge. A municipality brimming with community spirit welcomes visitors and newcomers alike, offering spectacular year-round festivals, recreational experiences and amenities. A third and fourth generation of residents grow up in Tumbler Ridge, supported by a safe community offering diverse housing and opportunities for young families. Tumbler Ridge is known for diversifying the local economy beyond natural resources and tourism, providing economic and employment stability for employees and investors alike. Tumbler Ridge thrives as a sustainable community that attracts visitors globally and where residents’ daily needs are met locally.
