

MESSAGE FROM THE MAYOR – June 2024

Dear Lytton Residents, Businesses, Property owners, and Community Members,

In just over one month, Lytton will have reached a three-year mark of the fire of 2021. Although our communication with you has vastly improved on the Village of Lytton Facebook page and the Village website, we recognize the need for more personal contact, such as this mailout.

Our Village Council has completed one and half years of a four-year term. Our challenges have been immense, yet we've kept our focus on moving forward with the rebuild of our town. I continue to be asked by media why the Village of Lytton's recovery has been so slow, and my answer is always that I believe there are a number of reasons, but our goal is to not let those first two years distract us as we work to keep moving forward.

I'm sure you have heard recently that the BC Auditor General's Office (OAG) is investigating the handling of Lytton after the 2021 fire. In a public statement the OAG said they are investigating the Province's roles and responsibilities for disaster recovery, their support for Lytton including the funding they contributed, and the challenges faced in rebuilding Lytton and opportunities for improvement. Their report will be released in early 2025.

If you've been following our council meetings, you will know that once a month we are provided an update on the number of building permits that have been issued and the number of inquiries made. As I write this message, building construction has started on seven properties in the Village. Three homes are at lock-up and others have foundations poured.

Many people ask about returning businesses and services. Council has approved the development permit for AG Foods grocery store, and I understand their application for a building permit is in process. The Chinese History Museum building is under construction, and the Legion is awaiting approval for their building permit. This month we met with Interior Health to discuss the permanent rebuild of the St. Bartholomew's Health Centre. We were told they plan to rebuild and that concept planning will soon be underway. When asked how long their building process will take, we were told it should be complete in three to five years. Like you, we look forward to hearing the plans for other commercial properties in the Village.

Municipal buildings are also in the planning stages. A concept plan has been developed for properties on Fraser Street, (formerly the museum, pool, and Totem Motel properties). To meet the requirements of the federal grant all building must be net-zero and function as public and inclusive space for all. A museum, visitor centre, and/or library would qualify. Our concept plan also includes outdoor event space, public washrooms, and a swimming pool. As these plans are finalized we will be communicating the information with all of you.

The visible building activity in the Village has provided a sense of optimism for so many in and around our community. Together, with our neighbouring Indigenous communities, we are moving forward. I encourage people to reach out to info@lytton.ca or any one of the council members with questions you have or clarification you need.
